We are advising the Securities and Exchange Commission (SEC), Philippine Stock Exchange (PSE) and the investing public that MacroAsia Catering Services, Inc. (MACS), 67% owned by MacroAsia Corporation (MAC) and 33% owned by SATS, Ltd. (Singapore Airport Terminal Services), in its regular board meeting today, 10 September 2025, has declared Fifty Million Pesos (Php50,000,000) cash dividends. The dividends are payable on or before 31 October 2025 to stockholders on record as of 15 September 2025. MacroAsia Corporation's share in this dividend declaration is Thirty-Three Million Five Hundred Thousand Pesos (Php33,500,000).

MACS, based principally in Manila, is a dominant provider of airline catering in the Ninoy International Airport (NAIA) and the Manila Domestic Airport (MDA).
