Please be informed that SNV Resources Development Corp. ("SNVRDC"), a wholly-owned subsidiary of MacroAsia Properties Development Corporation ("MAPDC"), inaugurated its water treatment facility in Solano, Nueva Vizcaya today, 30 July 2015. MAPDC is a wholly-owned subsidiary of MacroAsia Corporation.

MAPDC previously entered into an agreement with the local government unit of Solano to design, construct, commission and maintain a complete waterworks system in Solano, Nueva Vizcaya.

The water treatment facility is capable of producing 10-million liters per day of potable water, using the Magat River as source. The water treatment facility is expandable by another 5 million liters per day. Such treated water is potable, comparable if not better, and substantially cheaper than the ones bought at water purification centers.

SNVRDC will distribute this treated water to households and commercial establishments in Solano, through a new pipeline system that was laid out in the town.
