Please be advised that that Cebu Pacific Catering Services, Inc. (CPCS), a joint venture of MacroAsia Corporation with Cathay Pacific Catering Services of Hong Kong, and MGO Pacific Resources Corporation, in its regular board meeting on 28 November 2018, has declared PHP 105 million cash dividend payable on or before 30 December 2018 to MacroAsia Corporation (40%) and Cathay Pacific Catering Services of Hong Kong (40%) and MGO Pacific Resources Corporation (20%). MacroAsia Corporation's share in this dividend declaration is PHP 42 million.

Cebu Pacific Catering Services, Inc. (CPCS), formerly MATS Catering, is the first in-flight catering venture of MacroAsia Corporation (MAC). CPCS is the only full service airline catering company that operates at the Mactan-Cebu International Airport (MCIA).
